IMPORTANT GUIDELINES/RULES

BE SURE TO LIST THE ITEMS YOU WILL BE SELLING OR DISPLAYING IN YOUR BOOTH SPACE. THE CHAMBER RESERVES THE RIGHT TO REFUSE SPACE ON THE BASIS OF PRODUCT OR DUPLICATION.

DUPLICATION RULE IS IN EFFECT FOR PARTY PLAN TYPE VENDORS. WE ONLY ALLOW ONE PARTY PLAN/SHOW VENDOR OF A PRODUCT LINE. (EXAMPLE: MARY KAY/AVON/PAMPERED CHEF, ETC.)

IT IS VIRTUALLY IMPOSSIBLE FOR US TO PLACE A DUPLICATION RULE ON CRAFT OR OTHER ITEMS.

USED/YARD SALE TYPE ITEMS ARE NOT ACCEPTABLE. WE ARE ONLY ACCEPTING APPLICATIONS FOR FOOD, HANDMADE ITEMS, NEW ITEMS, INFORMATIONAL VENDORS.

THIS FESTIVAL IS A FAMILY EVENT AND VENDORS SHOULD EXERCISE CARE IN CHOOSING THEIR DISPLAY ITEMS TO MAKE SURE THEY ARE APPROPRIATE FOR CHILDREN TO SEE. WE RESERVE THE RIGHT TO HAVE YOU REMOVE THE PRODUCT(S) FROM DISPLAY ANY PRODUCTS WE FIND INAPPROPRIATE OR DANGEROUS. **NO KNIVES OR WEAPONS OF ANY KIND ARE ALLOWED.**

BEVERAGES AND FOOD FOR GIVEAWAY ARE PROHIBITED AS IT TAKES AWAY PROFITS FROM OUR FOOD VENDORS AND FROM THE CHAMBER'S FUNDRAISING DOLLARS.

VENDORS ARE NOT ALLOWED TO HAVE PATRONS PLAY GAMES AT THEIR BOOTHS FOR PRIZES.

THIS DOES NOT PERTAIN TO RAFFLES FOR QUILTS, ETC.

NO VENDOR IS ALLOWED TO DO A 50/50 OR ANY OTHER CASH DRAWING.

ALCOHOLIC BEVERAGES ARE NOT ALLOWED IN THE PARK. ANYONE VIOLATING THIS RULE WILL BE PAID A VISIT BY THE DELMAR POLICE DEPARTMENT AND POSSIBLY BE FINED OR ARRESTED.

ANY INDIVIDUAL OR BUSINESS SELLING FOOD ITEMS **MUST** MAKE APPLICATION TO THE **SUSSEX COUNTY HEALTH DEPARTMENT** FOR A PERMIT. THE HEALTH DEPARTMENT **WILL** VISIT THIS FESTIVAL TO MAKE SURE ALL VENDORS ARE PERMITTED TO SELL FOOD. FOOD VENDORS MUST DISPLAY THEIR PERMIT IN A VISIBLE LOCATION WITHIN THEIR BOOTH.

YOU MUST PROVIDE YOUR OWN TABLES, CHAIRS, HEAVY DUTY ELECTRICAL CORDS, AND SHADE UMBRELLAS, CANOPIES OR ANY OTHER SUPPLIES YOU NEED TO OPERATE YOUR BOOTH.

SHARING BETWEEN MULTIPLE VENDORS INSIDE ONE SPACE IS NOT ALLOWED. VENDORS MUST FIT THEIR ENTIRE DISPLAY INSIDE THE SPACE REQUESTED. **ANY SET UP OUTSIDE THE AREA WILL NOT BE ALLOWED AS IT INTERFERE'S WITH FOOT TRAFFIC PATTERNS.**

YOU MUST REPORT TO THE CHECK-IN TABLE LOCATED AT THE PAVILLION **BEFORE** SETTING UP YOUR BOOTH SO A VOLUNTEER CAN SHOW YOU WHERE YOUR BOOTH IS LOCATED. WE WILL NOT HAVE THIS INFORMATION FOR YOU BEFORE THE DAY OF THE FESTIVAL.

SET UP TIME IS 8:00 AM – 9:45.

ALL FEES AND RESPONSIBILITY RELEASE AND IDEMNIFICATION FORMS MUST BE SUBMITTED BEFORE SET-UP. **WE WILL NOT CHECK YOU IN PRIOR TO 8 AM.**

EARLY TEARDOWNS ARE NOT PERMITTED UNLESS THE CHAMBER CLOSES THE FESTIVAL. YOU NEED TO MAKE SURE YOU HAVE PLENTY OF PRODUCT TO LAST THROUGHOUT THE DAY. ANY VENDOR WHO TEARS DOWN EARLY MAY BE REJECTED FOR FUTURE PARTICIPATION.

IF YOU MUST CANCEL FOR ANY REASON YOUR FEE WILL BE REFUNDED TO YOU IF YOU NOTIFY US PRIOR TO May 17, 2024.

A \$50.00 FEE WILL BE CHARGED TO ANY VENDOR WHO'S CHECK IS RETURNED UNPAID FOR ANY REASON. WE MAY TAKE THE STEPS TO COLLECT THROUGH A COLLECTION AGENCY IF NEEDED.

ALL VENDORS WHO ARE PAID FOR JUNE 7th WILL NOT BE REQUIRED TO PAY AGAIN FOR THE JUNE 17th RAIN DATE AND WILL HAVE FIRST OPTION TO PARTICIPATE WITH APPROVED PRODUCT.

PARTICIPATION WITHOUT SIGNING AND RETURNING THIS FORM IS PROHIBITED.

PARTICIPANTS WHO OFFER ACTIVITIES INVOLVING PHYSICAL GAMES OR OTHER PHYSICAL ACTIVITY MUST PROVIDE PROOF TO THE CHAMBER OF COMMERCE OF THEIR OWN LIABILITY INSURANCE COVERAGE.

BE IT KNOWN THAT I WILL ASSUME ALL RESPONSIBILITY FOR MY PERSONAL OR MY GROUP’S BELONGINGS AND FOR ANY INJURIES WHICH MAY OCCUR AS A RESULT OF MY/OUR PARTICIPATION IN THE “DELMARVA’S DAY IN THE PARK FESTIVAL”. I/WE WILL NOT HOLD THE GREATER DELMAR CHAMBER OF COMMERCE OR ITS INSURANCE COMPANIES RESPONSIBLE FOR ANY INJURIES OR EXPENSES WHICH MAY OCCUR DURING MY/OUR PARTICIPATION.
